Dear Servicemember,

First and foremost, I would like to thank you for your bravery and service to our country. Without individuals such as you, America wouldn't have all the freedoms that we are able to enjoy.

In an attempt to try and protect those who do such a great job protecting us, I passed HB185 last year. This bill created a public records exemption for the identification and location information of current or former active duty servicemembers of the United States Armed Forces, their reserve components, or the National Guard who served after September 11, 2001, along with their spouses and dependents.

To have such exemption you must provide a written request to exempt the identification and location information from public disclosure, and provide a written statement that you have made reasonable efforts to protect the identification and location information from being accessible through other means available to the public. To assist you in protecting your identity, I have provided, in the following pages, the necessary forms and contact information that you will need to request this exemption.

INSTRUCTIONS FOR COMPLETION & SUBMISSION OF MILITARY EXEMPTION PAPERWORK

You must first be sure you have taken all reasonable steps to protect your identification and location information from being accessible through other means available to the public. This includes social media web sites such as Facebook, Twitter, Instagram, etc. If you have not done so, you will not be eligible for the public records exemption.

- 1. Complete the following form in its entirety, including any information for your spouse and/or dependent(s).
- 2. You will need one form for each Constitutional Officer (Clerk of Circuit Court, Property Appraiser, Sheriff Department, Supervisor of Elections and Tax Collector).
- 3. After completing the form, submit it to each Constitutional Officer in your county. A list of their contact information will be provided on the last page of this packet.

Should you find your information still listed publicly after your request form has been submitted, please contact the Constitutional Officer's office to confirm receipt. Should they not comply with this form, please contact Matt Gaetz at (850) 240-3778 or matt@mattgaetz.com.

Complete the following form in its entirety, including any information for your spouse and/ or dependent(s). You must also submit a copy of one of the following identifications with your Florida driver's license number and date of birth:

- Military ID
- Signed letter on agency letterhead from either your Commanding Office or Supervisor
- DD form 214

For your spouse/and or dependent(s), it is not required to submit their identification; however, they must live at the same address as the primary.
